

#### 1. The Dematerialization of Securities

Securities, once items of tangible property, have been transformed through legal maneuvering into mere contractual claims, leaving investors as unsecured creditors during insolvencies. It used to be that investors received tangible certificates as evidence of ownership of stocks and bonds. Now, however, physical certificates are rare, and everything is kept in digital form at clearing houses and custodians.

"This security entitlement severs the property right and essentially makes you an unsecured creditor to get your own securities back in the event of bankruptcy in the financial system." –David Rogers Webb

In the same sense that depositing money in the bank grants the bank ownership of your money and makes you a creditor who is simply owed money, securities are no longer your property.

When a bank is unable to provide its creditors with the money they are owed in the case of a bank run, like Silicon Valley Bank in 2023, creditors are given what they are owed in a certain order, until the money runs out.

"When you go deposit money in a bank, it no longer is your money. All of a sudden, they owe you that money and you may not have a right to it. If the bank fails... it's not your money. You line up as a lender to the bank, and the bankruptcy judge determines when and how you get paid, who gets paid before you and after you, and so forth." –Kevin Freeman



In such a bank run, if the money runs out before it is your turn to get your money, you lose it all. The same would be the case for your securities if there were a similar situation in the financial system.

Securities are insured by the SIPC which, like the FDIC, has a limited amount of funds allocated to insuring investors. Both insurance organizations could potentially run out of funds and be unable to fully insure your assets.

# Attention: Securities are being treated like money on deposit at a bank, making you incredibly vulnerable in the case of an insolvency event.

#### 2. Derivatives - The Biggest Bubble

The explosive increase in derivative contracts—firmly embedded via securities as collateral—poses a significant risk to the global financial system, potentially surpassing 20 times the global GDP.

The dollar value of the derivatives on the market is estimated to be over \$2.5 Quadrillion as of the end of 2022. This is 25 times the global GDP of about \$100 Trillion.

This derivative bubble is incredibly massive, and that is only the beginning.

"Derivative contracts are not real things themselves, but through this very sophisticated scheme, they can be used to take the real securities and assets from others." –David Rogers Webb

The Dot-Com Bubble of 2000 saw a \$1.755 trillion loss of value for Dot-Com stocks while global GDP in 2000 was over \$33 trillion.



The housing bubble of 2008 saw a \$6 trillion decline in housing value, while global GDP in 2008 was \$64 trillion. This came after the housing market collapsed by more than 50% of its peak value.

"I started becoming concerned about the scale of derivatives in the very early 2000s. And at that point, derivatives were about \$100 trillion to \$120 trillion. So about twice the global GDP at that point. Very large. Now, by 2007, 2008, this had gone to \$700 trillion. So, from \$100 trillion to \$700 trillion in five years. At that point it was ten times global GDP. It's now estimated that derivatives might be over \$2 quadrillion which would be maybe 20 times global GDP. Now, what has enabled this is the use of all the public's securities as collateral, free of payment and without restriction. That is the public's securities are held in these vast pools without any specific identification to securities so that they can be used as collateral by others underpinning the derivatives complex." —David Rogers Webb

If the Derivative Bubble were to collapse by even 5%, it would be a loss greater than global GDP. This is an unprecedented threat to the global economy and the financial systems we know today.

Attention: The Derivative Bubble poses a major threat to not only the American market but the global economy as well.

#### 3. The Great Taking & How to Fight Back

This threat has not gone unchecked by accident.

Over the last 25 years, the Uniform Commercial Code (UCC) has been adapted in all 50 states to include this dangerous possibility of a great taking.

In the event of insolvency, your securities can be taken because they aren't yours at all. Securities have been pooled together into bundles that are owned by a small group of powerful organizations.

Cede & Company currently owns 83% of all issued stocks in the United States.

Under the new UCC adaptations, they can legally seize those shares in the event of insolvency.

"What they did was to say that entitlement holders have priority over the secured creditors. And, for example, I went to South Dakota when they were beginning the process of hearing the bill. And I heard the bank lobbyists read only that much and stopped... It (the UCC) then goes on and says, 'EXCEPT,' and then you go to another period paragraph. And in the exception that also begins that the entitlement holders have priority over the secured creditors, 'EXCEPT.' So you have to drill down three levels, and then you find that the secured creditors have priority all the time over the entitlement holders."

-David Rogers Webb

In the "Great Taking" documentary, David gives an excellent analogy.

Imagine you go to your car dealer, you pay cash for the car, you buy the car, you drive it home, you drive it for a couple of years, you think it's yours. And then somebody shows up with a piece of paper and repos it from you.

What you didn't know is the car dealer had secured all of their loans, and debt, with the cars they had sold.

Currently, this is not the case with cars, but much worse, it is the case with securities. This is not only individual investments but also includes all securities held in large pension plans and retirement funds.

"The right to securities is property. We can tell they're going after other types of property as well. But the securities issue, this was subverted in local law in every case the individual nations in the EU and all 50 states. And it is actually a shockingly simple thing to see when you actually look at the language in the UCC, it's plain as day. Oh, the deception." –David Rogers Webb

4. There appears to be a final plan, one more step in the globalist elites' plan to own everything for us so that we will "own nothing and be happy." For this to happen, insolvencies across the board are a necessity.

For them to own all these securities, giving them complete control over every publicly traded corporation in the world, **they need insolvencies across the board**.

Question: What causes mass insolvencies? Well, every major market crash has seen insolvencies, like Lehman Brothers in the 2008 housing crash.

For insolvencies to happen at scale, it would require an economic disaster of unprecedented proportions... like the bursting of the derivatives bubble.

"It's a very sophisticated sleight of hand where the failure is actually necessary for them to take everything." –David Rogers Webb

The failure of the markets and the collapse of derivatives are essential for the capture of the global markets.

5. There is a solution, the answer is to start working through your state legislators and removing the exception wording in the UCC reatled this topic.

David recognized that this entire strategy hinges on one word in the UCC.

"The simple thing is to eliminate the exception; you just strike it out. The entitlement holders have priority all the time." –David Rogers Webb






