Ken Ivory is a state representative for District 39 in Utah. He has been fundamentally involved in the success of multiple bills in the state and worked directly with Kevin when he consulted for the Utah Federal Funds Risk Commission.

#### 1. Utah – A Monetary Leader

Back in 2011, Utah led the charge with the Utah Legal Tender Act. Ken Ivory played a crucial role in the drafting of that bill.

The Utah Legal Tender Act made gold and silver coins legal tender in Utah. However, the gold and silver coins are not practical for daily use and cannot easily be broken down into smaller denominations.

The passing of this bill into law in Utah paved the way for many other US states to adopt similar legislation over the next few years.

This was a major steppingstone in the fight for state's rights and has helped to inspire the effort for transactional gold and silver.

"We've got a federal government that has its hand in the cookie jar, but only this time that cookie jar is our earnings, our savings, our property that is embodied in our money. And it used to be that money was a fixed standard... now they're just printing the value out from under us. And we're not going to stand for that, for us and our people... So, we're moving forward to have transactional, functional gold and silver in Utah to protect the purchasing power of the earnings and savings of the people of Utah." –Ken Ivory

As the US Dollar is no longer on the gold standard, its fiat currency status has been eating away at the buying power of the American people.

Transacting in gold or silver lessens or even nullifies the impact of inflation over time.

For the people of Utah, and hopefully all Americans, transactional gold and silver would take the Legal Tender Act to the next level by making transactions in gold or silver practical and more affordable for the average citizen.

"There are four key components. Number one is the functional, transactional ability for gold and silver that preserves Utahns from being devalued, debased, and demonetized. The second part is the ability to pay taxes in gold. And why that's important is that advances the argument that gold is money and not an asset



subject to capital gains. The third thing that we do is we allow for our good treasurer to invest some of our rainy-day fund into precious metals, gold, and silver. Like all the central banks of the world are doing at breakneck pace. The fourth thing is we allow for the state to issue bonds denominated in gold. I mean, imagine if you could buy a 30-year municipal bond investment once denominated in dollars, the other one's denominated in gold. Pretty easy answer which one you would choose, which could substantially lower the cost of our debt." –Ken Ivory

Obviously, it is essential for gold and silver transactions to be practical for people to adopt it, and with the transactional gold bill Ken Ivory is proposing, that would become a reality.

By allowing citizens to pay their state taxes in gold, the IRS would be hard-pressed to find a way to place capital gains tax on the gold in this system.

Utah would also take advantage of the opportunity to buy up gold as a safe haven for the State in case economic conditions were to worsen drastically. As Ken points out, many central banks around the world are already stocking up on gold.

Ken also poses the option for bonds denominated in gold which would provide more stable returns on investment and would have the potential to lower state debts.

Attention: The federal government has been siphoning money out of the hands of the people while printing enough money to crush the buying power of the Dollar. Utah is bringing forward a potential state-based solution with transactional gold and silver.

#### 2. CBDC & The Golden Alternative

The damage done by excessive printing and federal government spending is not the only threat to the American people.

"What we're seeing is an unprecedented attack on economic freedoms unlike we've ever seen in this country. And it goes, everything from ESG, to natural asset companies, to central bank digital currencies. All of these things threaten our economic freedoms. The central bank digital currency, probably the most direct and, problematic of



all of them. This legislation, particularly the transactional piece of this, is meant, I think, to really help us to have an alternative where we can transact without having to be beholden to a central bank digital currency." –Marlo Oaks

Globalist elites have been working toward global control for decades. A quote that has been mistakenly attributed to Henry Kissinger states, "He who controls the food supply controls people, who controls energy can control whole continents. Whoever controls money can control the world." Rings true regardless of who said it.

The threat of Central Bank Digital Currency is that it would give the elites control of every aspect of life by controlling every cent people have or spend.

They have already gained too much power over the people through fiat currencies like the US Dollar where inflation whittles away at the wealth of the American people.

"When Nixon took us off the gold standard... in 1971, you could buy an average home for ... about 17,000 grams of gold (roughly \$25,000). Today we're talking about housing affordability and dumping government money after that. If a house costs \$600,000 today, (the 1971 price) doesn't get you anywhere close to a down payment. But Kevin, the 17,000 grams of gold would buy you almost two houses today. That's the value that's been taken right out from under us. And it's a tax that people don't even recognize. But it really is stealing the wealth right out from under Utahns and Americans." –Ken Ivory

The US Dollar has plummeted in buying power since the 1970s. Gold, on the other hand, has maintained its value and in some cases has even gained value.

This is evidenced not only by the housing market but by many commodities. <u>PricedInGold.com</u> provides multiple charts for users to see the value of commodities over time, priced in gold.

If the average American were paid their salary in gold, their annual income would have maintained or gained buying power over the years. Sadly, being paid in US Dollars has meant that the buying power of



an

American citizen has declined, even as the average income has increased.

This is not simply a byproduct of poor monetary policy, it is being used as a weapon.

Globalist elites are using the declining buying power of the American people to strip them of the ability to resist. With less money people are less capable of providing for their needs and more people become dependent on the government.

Central Bank Digital Currency will give them even more power, but they are crushing our wallets to ensure we allow them to implement it.

"There are many scholars who believe the Constitution gives Congress the right to create such a monster. I mean, they can coin money, right? And so, a lot of people say, well, that's inherent in it and the government has that right. Well, if they claim that right, we have to fight them in the courts. We have very little recourse until we can get it finally stamped and killed. But



Representative Ivory, you once again have come forward with an offensive strategy with transactional gold and silver in your House bill that gives the state legislature the ability to create this alternative so that people can opt out of central bank digital currency and opt into Utah's gold and silver." –Kevin Freeman

Our ability to resist the rise of a Central Bank Digital Currency lies entirely in our ability to create an alternative system.

Even if we were to succeed in legal battles, Central Bank Digital Currency would be implemented for months or years before the case reached a conclusion. During that time, they could strip funding from the opposition or even cancel accounts of opposition members, starving the competition.

We cannot afford to wait until CBDC is a reality, we must act now and build a parallel system that ensures financial liberty and economic justice to protect the American people from tyranny.

"It's really about options. You know, Alexander Hamilton said we may safely rely on the state legislatures to erect barriers against the encroachments of the national authority. And we're seeing those encroachments like Marlo mentioned, there's a push to even get to the point that they control what we do. And those that are backing central bank digital currencies are kind of giddy about it. We can control what they eat and where they drive and where they travel. And heaven forbid if they buy guns or ammunition. And, you know, our money is a representation of our liberty... that's the ultimate control mechanism. And we're seeing government centralizing... this is the Holy Grail that, those that want centralized control are after." –Ken Ivory

The state legislatures are directly responsible for developing and passing legislation that is in the best interest of the citizens of their state. It is also the responsibility of the states to protect the people from federal overreach.

This is the first and most essential check and balance in the constitution, that the people and the states are to challenge federal attempts at tyranny, thus maintaining the republic.

As the federal government is pushing for CBDC, it is abundantly clear that the states must rise up against it by building an alternative option that protects the American people and preserves their liberty.

"Most people don't realize that what the BRICS are (the Brazil, Russia, India, China, South Africa trading block). They just invited all the oil-producing countries in, and as of January 1st, 2024, they're now trading oil in currencies other than the dollar... This year, the indebted United States has to go into the capital markets for more than \$13 trillion. We overspend by \$2 trillion/year. The interest is \$1 trillion, and \$10 trillion of the \$34 trillion rolls over this year... we can't force countries to buy the dollar anymore because they don't need it for oil. This is quite a distressing situation. And so, to give people options, we want to give Utahns the option. They have a better choice to store their earnings and savings. And, you know, this is the way that we're moving forward. We invite all other states to join us in this. It's very critical at this time. This is not like the times of before. This really is mission-critical right now." –Ken Ivory

CBDC is not the only threat. American national security, and the prevention of a rise of other global powers, has primarily been maintained by the dominance of the US Dollar.

Utah is beginning the process of making transactional gold and silver a reality with <u>House</u> <u>Bill 348</u>. Since taping, The Utah House voted 52-8 to pass a study bill that will pave the way for implementation in the next legislative session. 


