He also served four years as a city councilman in Lewisville, Texas. He earned his Juris Doctor from the University of Mississippi and his Bachelor of Arts in history from Harding University.



### 1. Debanking – An Economic Gulag

Debanking is a new term, often 'debunked' by the mainstream media, that describes scenarios where individuals find themselves cut off from their bank and are suddenly unable to participate in the economy.

This issue mirrors tactics reminiscent of the Chinese Social Credit system, targeting the financial capabilities of those with differing beliefs. It directly opposes the core American values of freedom of speech and association, laying the groundwork for a controlled and monolithic society.

“ Our founders were certainly concerned about the concentration of power, particularly at the federal government. But when you combine the concentration of power at the federal government level with the concentration of power in the financial and tech sectors in our country, if those two entities are working together, it presents a huge threat to liberty. I mean, basic access to basic financial services, is essential to everyone in this country and to be denied access to that based on religious beliefs or political beliefs, is certainly un-American. And if the federal government is involved directly or indirectly, it’s unconstitutional as well.” –Lathan Watts

Debanking has been revealed as the next step after the all-too-common de-platforming that became the norm during the Covid pandemic.

Individuals who spoke out against the official narrative were silenced, their social media accounts were shut down, banned, or throttled.

This was not enough for some. People like Nick Vujcic, Nigel Farage, and Sam Brownback have experienced the shutting down of their bank accounts due to their political and religious beliefs.

Stripping people of access to financial services is a direct infringement on the right to property which is essential in the pursuit of happiness.

The process of infringing on these rights began under the Obama Administration with Operation Choke Point, which targeted businesses deemed as ‘reputational risks’.

“What we’ve seen is seven of the ten largest banks in the country have these really vague terms of service with terms like reputational risk, or that they won’t do business with things that promote hate or intolerance. Well, how do you define hate? How do

“you define intolerance? How do you- what is reputational risk if you do business with someone?” –Lathan Watts

Today, the threat of being de-platformed, or debanked, is ever-increasing as companies are able to define for themselves what a ‘reputational risk’ implies.

Athletes can lose sponsorships, influencers can lose their social media accounts, and now customers can lose their bank accounts.

**⚠ Attention: The threat of debanking looms ever closer, as some of the most famous and influential people in the world have lost access to financial services due simply to their political and religious stances.**

## 2. Government and Private Sector Collusion

The concept of controlling money as a means to control liberty isn’t new and can be traced back to the founding of America.

The thirteen colonies were financially controlled by the English Crown, with policies designed to control colonists and ensure that the interests of the crown were secured throughout the empire.

Parliament, and the King, did not wish for the American colonies to be self-sufficient. They could not control food, or expansion easily. However, they could control the money.

For this reason, the founders of our nation designed a government that would not allow the federal government to have such controls.

“The really tight relationship between banks and federal regulators is really the most dangerous part of this. And that’s what we saw at the subcommittee hearing, was that the Treasury Department had gone to the largest banks in the country and basically asked them to, basically surveil their customers and look for transactions or interactions, with places like Dick’s Sporting Goods, Cabela’s, purchasing of religious texts, donating.” –Lathan Watts



To sneak around the law and control people without it being obvious, the government colluded with big business.

This is a form of fascism, which was defined by Mussolini as “a merger of state and corporate power.”

The debanking phenomenon marks an alarming evolution in how power can be exercised over individuals and groups, by directly ignoring constitutional safeguards.

Elon Musk found the same to be true of deplatforming as certain posts and accounts were removed from Twitter at the request of democrat leaders.

Freedom of speech and the right to own property cannot be infringed if liberty is to prevail. Both are foundationally necessary for the existence of a free people.

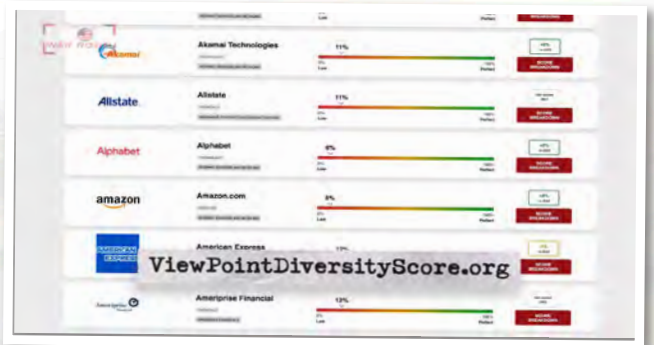


**Attention: Large corporations and banks have been colluding with government officials to gain more control over political opposition and to silence those who would speak out against their policies.**

“The third version of that score is getting ready to come out very soon. So you can see it focuses on mostly big finance and big tech companies, because that’s where the concentration of power that is able to impact people’s daily lives the most. That’s where we see it. And so you can arm yourself with information that way. Another thing is to know where your money is invested. If you’re a shareholder in a company like Bank of America, Chase, Wells Fargo, I mean, this handful of really big banks control over half the deposit accounts in the country, you need to know where your money is invested. If you’re a shareholder, you can support shareholder resolutions.” –Lathan Watts

With debanking becoming a more common issue, it is essential to keep your money in a safer bank where they are less likely to lock you out of your account for political reasons.

As globalist elites work toward total control, American patriots must stand against them by wielding their finances as a weapon.

The principles of life, liberty, and the pursuit of happiness are under subtle siege by forces that seek to control and conform our beliefs under the guise of financial regulation and security.

By standing informed, united, and resolute in our actions, we can defend our freedoms and ensure that America remains a land where liberty and financial independence are inalienable rights, not privileges awarded for ideological conformity.

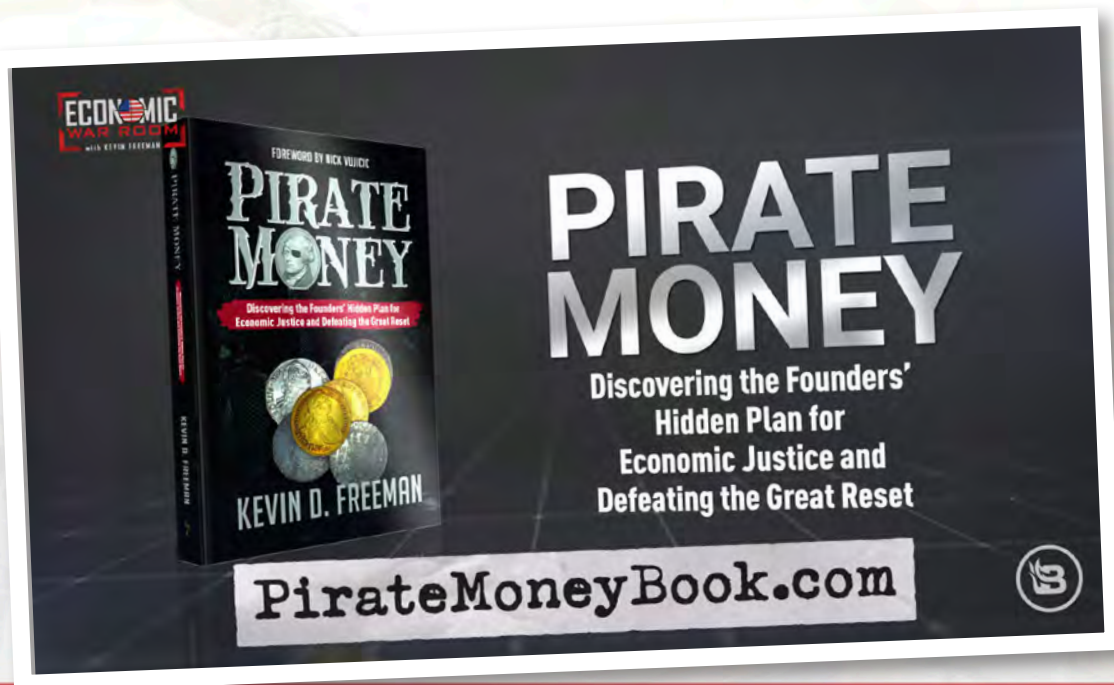

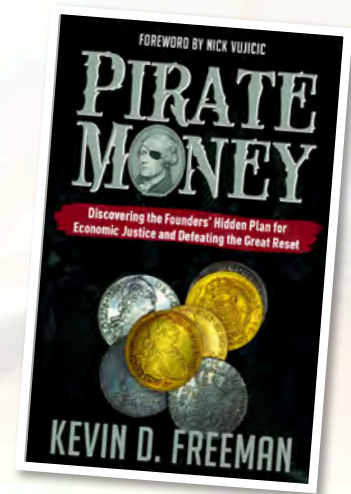
