#### 1. The Weaponization of Financial Regulations - "Reputational Risk"

The weaponization of financial regulation is the process through which unjust restrictions on businesses and consumer freedoms, along with targeted financial exclusions are used to control the market based on political biases, which can reach into everyday aspects of citizen's lives such as banking services or political donations.

These regulations allow bureaucrats to coerce businesses into transforming their company policies and structures to ensure they do not end up on the regulator's naughty list.

"The main goal of financial regulation in the United States is supposed to be the protection of consumers, investors, and their businesses from deception and fraud. Government agencies such as the Securities and Exchange Commission and the Federal Deposit Insurance Corporation should protect our interests and property rights from

bad actors and criminals. Yet, in far too many cases, the financial regulatory agencies that are supposed to be our useful servants have become arrogant masters." –Richard Morrison

Regulators use the term 'reputational risk' to brand people or businesses they disapprove of as liabilities.



This deters businesses from legitimate activities and stifles their freedom to operate based on contrived pressures while reinforcing a conformist business culture lacking diversity of thought and action and hampering innovation.

This destabilizes trust in financial institutions and limits freedom of commerce and expression within a supposedly free-market economy.

"Regulators are creating this risk out of nothing... they control the levers of power. They're regulating the banks. So the fact that they say there's something negative with your clients, by definition, creates reputational risk out of nowhere. Because if the regulators are looking askance at your business, they have the power, even if no one else in the world cares, even if no one else thinks that what you're doing is negative. The fact that the people holding all the law enforcement power are looking down their noses at you means they have created reputational risk where none existed before, and then they try to force you to follow their preferred policies because of that." –Richard Morrison

These forms of regulatory control started with Operation Choke Point during the Obama administration.

This operation was secretive, working to force small businesses to conform to a political agenda or lose their ability to do business. One of the primary targets was firearms dealers.

Attention: Regulatory abuse allows politically charged bureaucrats to manipulate American businesses and silence political opposition, directly infringing on the rights of American citizens.


#### 2. Threat to Small Businesses and Economic Diversity

Over-regulation leads to a homogenized economy dominated by larger corporations less susceptible to regulatory retaliation.

Small businesses often depend on financial services, especially banks, to remain operational. Large corporations, on the other hand, are powerful enough that they can often survive these regulations.

Using these regulatory abuses, the Obama administration was able to put pressure on small businesses that did not align with their political agenda, thus incentivizing specific behaviors that favor globalist ideals.

"The regulators in the Obama era (the Treasury Department, FDIC, and other bank regulators like the OCC) decided they simply didn't like certain kinds of businesses and especially certain kinds of small businesses. So using their influence as regulators of bigger banks, they went to banks and said, 'You have all these small business



clients here and they're sort of politically controversial. So maybe it would be better if you cancel their accounts and didn't service them anymore'...This wasn't a plan that was announced anywhere, and it certainly wasn't something that was authorized by Congress." –Richard Morrison

Overreach by financial regulatory bodies jeopardizes democratic principles of fairness, transparency, and accountability, skewing the free market. It fosters, instead, a centralized state with unchecked power, contrary to the foundational principles of our constitutional republic.

Attention: Selective pressures and account closures disproportionately affect small businesses, limiting economic diversity and innovation.

#### 3. CBDC – The Globalist 'Death Star'

The next big step for the globalists who authorized these regulatory abuses is to develop a Central Bank Digital Currency.

CBDC's will grant globalists centralized financial control, undermining privacy and autonomy over personal finances, including imposing restrictions on spending based on surveillance.




