1. Corporate Transparency Act's Impact on Small Business

The Corporate Transparency Act (CTA) requires small businesses to disclose beneficial ownership information to FinCEN, ostensibly to prevent money laundering and other financial crimes. However, the implications for small business owners are profound:

"If you don't file with this entity inside the US Treasury Department... You can be deemed a felon if the government chooses to enforce the law, whether you know about it or not. Ignorance of the law is no excuse. You can be fined up to \$591 and some odd dollars a day, for noncompliance, or sentenced up to two years in prison for simply not handing over this basic information." —Jacki Deason



Non-compliance could result in fines of \$500 per day, felony charges, and imprisonment. Critics highlight the inequity in excluding large corporations from these requirements, leaving smaller entities disproportionately affected.

This law targets small businesses, defined as entities with fewer than 20 employees or less than \$5 million in annual revenue, excluding larger corporations.

The requirement to report personal details like Social Security numbers poses a risk of identity theft and privacy violation, especially since this information could be shared internationally with over 170 other nations.



Attention: The CTA could criminalize millions of small business owners for non-compliance due to a lack of awareness or understanding. Thankfully, a district court in Texas placed an injunction that (temporarily) prevents enforcement of the law.

1. Congressional Oversight and Legislation Process: Overreach and Weaponization

The CTA's passage through the NDAA highlights systemic flaws in legislative practices.

Congress often passes laws without a thorough review. It is a commonly accepted reality that there are too many bills, and they are all far too long for members of Congress to have performed a detailed analysis of each. Yet they vote on them every year, passing many into law.

The lack of detailed understanding by legislators can result in laws, like the CTA, being passed that serve political or bureaucratic interests over the public good. Sometimes they are malicious and invasive.

This process can lead to the weaponization of legislation against certain groups or political adversaries, as highlighted by historical examples of IRS targeting during the Obama administration (Operation Choke Point).



Attention: Legislation can evolve into tools for political gain, impacting American citizens based on their affiliations or political/religious expressions instead of real criminal activity.

2. Legal and Constitutional Challenges

Thankfully, the CTA already faces legal scrutiny for potentially violating constitutional rights:

Challenges against the CTA argue it infringes on privacy and property rights.

Although initial legal victories were limited to specific plaintiffs, broader constitutional rulings could offer relief to all small businesses, questioning the government's right to such intrusive data collection. And there is a court injunction proventing enforcement. At least for the



injunction preventing enforcement. At least for the time being.

The deadline for submitting such data to the government was early January and a final ruling that would throw out the law could take much longer. Thus, it is essential to be aware of and on top of this law and its challenges.

Even if Donald Trump were to get rid of the CTA, there would have been three weeks under Biden where the law was in effect and business owners who did not submit their information would face felony charges. Fortunately, the last-minute injunction provides a reprieve.

3. The Timely Federal Court Injunction That Provides Breathing Space

On December 3rd, a Texas court produced the following ruling:

Having determined that Plaintiffs have carried their burden, the Court GRANTS Plaintiff's Motion for a Preliminary Injunction. Therefore, the CTA, 31 U.S.C. § 5336 is hereby enjoined. Enforcement of the Reporting Rule, 31 C.F.R. 1010.380 is also hereby enjoined, and the compliance deadline is stayed under § 705 of the APA. Neither may be enforced, and reporting companies need not comply with the CTA's January 1, 2025, BOI reporting deadline pending further order of the Court. https://s-corp.org/2024/12/cta-struck-down-by-texas-court/



Attention: Legal challenges to the CTA highlight its potential flaws, but if the injunction were withdrawn or defeated on appeal, compliance would remain critical until definitive rulings are made.

Note: An appeal has been filed, and the Appeals Court could reinstate the ruling as soon as December 27. Watch the news carefully, as compliance by January 1 could theoretically be reinstated. We believe that would be extremely unfair, giving small businesses just a few days to file.





Debanking and the Return of Operation Choke Point
