1. De-Banking: Political Discrimination

In summary, the Government warned banks that people who made certain purchases were deemed as “less desirable” customers in the eyes of regulatory agencies. This pressured banks to give up client information without permission or a warrant.

These practices equate to unreasonable search and seizure, violating constitutional rights. Banking surveillance erodes consumer trust and puts sensitive data at risk of misuse. And this became a political weapon to silence dissent or viewpoints opposing the current regime.

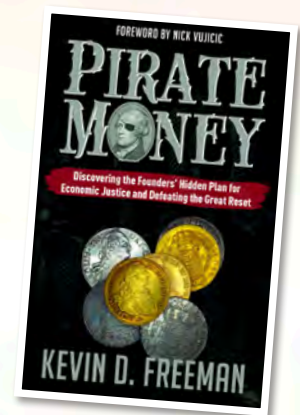
