1. The Government-Orchestrated Conspiracy to Undermine Donald Trump

The operation reportedly began as a means to divert public attention from Clinton's own email scandal, which involved the mishandling of classified information on a private server—a potential violation of the Espionage Act.

"It was Hillary Clinton coming up with a political, dirty trick to make Donald Trump look like he had a Russia problem when Donald Trump didn't have a Russia problem. But then she enlisted and engaged the use of our intelligence and our law enforcement communities, the FBI and the CIA, to carry out that ruse, to give it legitimacy, to cause people



to have their civil liberties violated, to have their freedoms put at risk, to have their reputations destroyed on a false political dirty trick." –John Solomon

When then-FBI Director James Comey declined to prosecute Clinton, it created the conditions for this broader strategy to take root. The decision signaled that powerful political figures could avoid legal consequences, even when the alleged violations were serious.

That perception of immunity was reinforced by the conduct of FBI officials Peter Strzok and Lisa Page, whose private text messages revealed strong anti-Trump bias while they played pivotal roles in the Crossfire Hurricane investigation.

Their actions, and the perception of partisanship they fueled, further undermined public trust in the impartiality of federal law enforcement.

Together, these events set a dangerous precedent: one in which political operatives, aided by government institutions, can weaponize false narratives to damage opponents, shape public opinion, and alter the course of elections.

The implications of that precedent would ripple far beyond 2016, becoming a central element in what is now being investigated as a broader, decade-long conspiracy. Trump was undermined from the beginning, ultimately leading to his impeachment and lasting into outright lies to prevent his reelection.

2. The "Grand Conspiracy Case" and Legal Strategies for Accountability

For most Americans, it was obvious over the last few years that Trump and his team were regularly accused and indicted, meanwhile Hillary Clinton and Joe Biden were both cleared of their crimes.

"Hillary Clinton has a classified email problem. Joe Biden has a corruption problem in Ukraine with his son. Joe Biden has a classified documents problem in his garage, in his private office. And in each of those circumstances, they instead clear those people, don't give them any consequence, and they use



the machinations of government, the FBI, the special prosecutors, the intelligence community to make it look like Donald Trump has a similar or worse problem—in the case of Russia collusion, completely invented; in the case of Hunter Biden, the Ukraine impeachment, completely invented; in the case of the classified documents, yeah, Trump had some classified documents in his place, but he was allowed to declassify and take them—Joe Biden wasn't. But they criminalized Donald Trump, and they let Joe Biden walk."—John Solomon

As this two-tiered justice system has unraveled and evidence has been compiled, it has evolved into what is now referred to as the "Grand Conspiracy Case."

This ongoing FBI investigation is probing a decade-long pattern of alleged government misconduct, tying together events ranging from Russiagate to the Ukraine impeachment and the Mar-a-Lago raid.

The central legal theory holds that these incidents are not isolated, but part of a single,

continuous criminal enterprise under the Racketeer Influenced and Corrupt Organizations Act (RICO), which allows prosecutors to connect separate acts into one cohesive pattern.

"What's happened is the body of evidence has given rise to an FBI investigation called the Grand Conspiracy Case. And it looks at the last ten years and that wash, rinse, and repeat cycle I just laid out as one ongoing criminal conspiracy to deprive Americans of their civil liberties under the color of government authority." –John Solomon

By framing these actions as an ongoing conspiracy, prosecutors could bypass the standard five-year statute of limitations, enabling potential charges for conduct dating back to 2016.

The case may also be moved to Florida, a more politically balanced venue, to avoid the heavily partisan jury pools of Washington, D.C.

Such a move would open the door for scrutiny of high-profile figures, including Hillary Clinton, former FBI officials, and intelligence leaders such as John Brennan and James Clapper.

"Well, if you could do that and you absolutely can try it in Florida and the statute doesn't apply, then you could bring Secretary Clinton, you could bring the FBI leaders, you could bring Brennan and Clapper and all of them in. But you can't bring President Barack Obama, who likely was a key part of all of this, because he can't be charged for official acts.



So, what do you do with President Obama?" -Kevin Freeman

This strategy could lead to major indictments, sweeping restructuring of intelligence agencies, and even compel sworn testimony from former President Barack Obama—who, due to presidential immunity, could not invoke the Fifth Amendment to avoid answering questions.

Any false statements under oath would carry the risk of perjury, and he could still be named an unindicted co-conspirator, potentially reshaping his legacy.






