Frank Gaffney is the President of the Institute for the American Future. In addition, Mr. Gaffney is the host of "Securing America," a daily program on the Real America's Voice network and podcast; the driving force behind SecuringAmerica.Substack.com; and the author of a daily audio and video commentary, the "Secure Freedom Minute."

Mr. Gaffney is also associated with the various coalitions supported by the Institute. For example, he serves as the Vice Chairman of the Committee on the Present Danger: China (CPDC) and the co-founder of the Sovereignty Coalition (SovCo).

In 1987, Frank Gaffney was tapped by President Ronald Reagan at the age of 34 to become the Assistant Secretary of Defense for International Security Policy after his four years as the Deputy Assistant Secretary of Defense for Nuclear Forces and Arms Control Policy. He went on to found and lead for thirty-seven years the Center for Security Policy to champion the practice of what "the Gipper" called "peace through strength" through a high-impact/low-overhead model Mr. Gaffney dubbed "the Special Forces in the War of Ideas," now being practiced at the Institute for the American Future.



1. Sharia as an Existential Threat to Texas and America

Sharia law is often described in Western discussions as a personal religious code guiding moral behavior.

In reality, Sharia is a body of religious law derived from the Qur'an, the Hadith, and centuries of Islamic jurisprudence. In many societies, it has functioned as a comprehensive system governing civil law, criminal justice, finance, family matters, and social order.

For policymakers and analysts studying the issue, the concern is not theoretical. Modern history provides clear examples of how societies can rapidly transform when movements committed to establishing Sharia gain political power.

Historical Example: Iran's Islamic Revolution

Prior to 1979, Iran operated under a secular monarchy with expanding modernization, education, and social freedoms. Iranian women attended universities, held professional careers, and participated broadly in civic life. Persian cultural heritage—rooted in ancient traditions of poetry, music, and secular governance—flourished alongside these efforts.

The 1979 Islamic Revolution, led by Ayatollah Ruhollah Khomeini, overthrew the government and established an Islamic Republic governed by Sharia-based law. Almost overnight, Islamic courts replaced secular institutions, strict religious codes enforced dress, speech, and public conduct, and political dissent was brutally suppressed.



Revolutionary courts conducted rapid trials and executions of opponents. The regime's consolidation included mass killings: thousands of political prisoners (communists, socialists, liberals, moderate Islamists, and others) were executed in the early 1980s under Khomeini's fatwas, culminating in the 1988 mass executions of 2,800–5,000 or more already-sentenced prisoners through summary trials.

Universities closed during the Cultural Revolution, non-conforming academics were expelled, and “un-Islamic” elements of Persian culture faced systematic censorship and destruction.

The result was the devastation of a once-vibrant, culturally diverse society, replaced by a repressive theocracy that continues to crush dissent, limit freedoms, and enforce ideological purity over individual rights and heritage.

Developments in Europe

These patterns are not confined to the Middle East. In Europe, large-scale immigration from Sharia-adherent communities has led to incremental but alarming changes, creating parallel societies and eroding freedoms.

In the United Kingdom, Sharia councils operate as arbitration bodies for religious divorces and family disputes within Muslim communities, with parliamentary reports raising concerns over polygamy, unequal custody, and discriminatory inheritance. Grooming gangs—often tied to cultural attitudes influenced by Sharia views on non-Muslims and women—exploited thousands of vulnerable girls, with authorities sometimes hesitant due to fears of racism accusations.

“No-go zones” have emerged in parts of cities in France, Sweden, and elsewhere, where police face resistance entering neighborhoods dominated by Sharia-influenced populations.

Women face growing pressures: enforcement of dress codes, elevated risks of honor-based violence, forced marriages, and informal Sharia family rulings that undermine gender equality. Threats against apostates and critics include violence or severe punishments, stifling free speech and religious liberty.



In many reported cases, European women dressed in modern clothing are assaulted or even raped by Muslim men who, under Sharia, see this attire as an invitation for assault or even see this as punishment for the woman’s ‘immodesty’.

In England, estimates have reached upwards of 1 million British children who were raped or even sex trafficked by Muslim grooming gangs. This has become a major political talking point as major UK officials have refused to address this issue head-on for fear of being called racist.

International organizations have warned that certain interpretations of Sharia conflict with modern human rights standards, particularly on equality before the law and protections for women and minorities.

Why the Debate Has Reached the United States—and Texas

These examples illustrate a broader pattern: when religious legal frameworks operate within democratic societies, they gradually create parallel expectations and norms. The concern is not private belief but preventing any alternative legal authority from influencing civil governance.

In Texas, with over 330 mosques (many linked to entities like the North American Islamic Trust), projects tied to groups such as the East Plano Islamic Center, and broader demographic shifts, similar patterns are taking root. This forms part of the “Four Horsemen” threats—advancing incrementally, like a frog slowly boiling, while awareness lags.



The American constitutional system depends on a single governing framework. Parallel systems make maintaining equal rights and consistent standards far more difficult.

If Texas—the strategic conservative linchpin—falls to this infiltration, the implications extend nationwide.



Attention: Iran’s destruction of its own rich pre-revolutionary culture through violent imposition of Sharia, combined with Europe’s experiences of parallel societies and eroded freedoms, illustrates the real-world outcomes Sharia adherents seek to replicate in America—starting in targeted strongholds like Texas.

2. Five Constitutional Conflicts with Sharia Every American Should Understand

Sharia, as a comprehensive political and legal system, directly conflicts with core principles of the U.S. Constitution in several fundamental ways. To understand the debate clearly, it is helpful to compare traditional Sharia jurisprudence with the foundational safeguards of our constitutional republic.

“Sharia fails to include due process, treats non-Muslims as second-class citizens, and prescribes barbaric punishments... This is a death cult. Let’s be honest, it does not earn, nor should it receive the protections that actual religions which worship a deity that is benign and that is loving and that is encouraging of individualism, especially to have the protections of our First Amendment, our constitutional right to freedom of religion” –Frank Gaffney



These incompatibilities are not fringe interpretations but stem from core Sharia principles that demand total submission, making any implementation as governing law antithetical to the Constitution’s emphasis on individual liberty, equality, and secular rule of law.

Here are the **five key constitutional conflicts** every American should understand:

1. **Religious Freedom vs. Apostasy Laws:** The First Amendment guarantees the right to free exercise of religion—including the freedom to change religions or reject religion entirely—without government interference or penalty. Traditional Sharia jurisprudence treats leaving Islam (apostasy) as a serious offense, historically punishable by death in many interpretations, directly clashing with this protected liberty.
2. **Freedom of Speech vs. Blasphemy Restrictions:** The First Amendment protects speech that criticizes religion, challenges authority, or expresses dissenting views, even if offensive. Sharia-based systems often include blasphemy laws that criminalize insults toward Islam, the Qur’an, Muhammad, or Allah—potentially punishable by severe penalties, including death—undermining this core protection.
3. **Equal Protection vs. Gender-Based and Religious Distinctions:** The Equal Protection Clause of the 14th Amendment, along with the First Amendment’s prohibition on religious establishment or favoritism, ensures equal treatment under the law regardless of gender or religion. Traditional Sharia includes distinctions that subordinate women (e.g., unequal inheritance where daughters receive half of sons, testimony valued at half a man’s in certain cases) and treat non-Muslims as second-class citizens (dhimmi status with inferior rights and protections), violating these guarantees.

4. Due Process, Fair Trials, and Prohibition on Cruel Punishments vs. Sharia


Criminal Penalties: The 5th, 6th, 8th, and 14th Amendments provide for due process, jury trials, fair hearings, and bans on cruel and unusual punishments. Sharia prescribes hudud punishments—such as amputation for theft, stoning for adultery, flogging for various offenses—often without modern standards of due process, jury trials, or evidentiary safeguards, making them incompatible with constitutional protections.

5. Separation of Church and State / Constitutional Sovereignty vs. Theocratic Authority

Authority: The Establishment Clause and overall secular framework ensure no religious doctrine governs civil law, with the Constitution (per Article VI) as the supreme law of the land. Sharia integrates religious doctrine directly into governance, insisting divine Islamic law overrides man-made constitutions and clerical interpretations hold ultimate authority—undermining the separation of religion and state and the singular sovereignty of the Constitution.

Sharia also highlights the ‘prophet’ Muhammad as the ideal man; in so doing, it not only justifies his behavior but also encourages others to live like him: Beheading infidels, marrying six-year-old girls, raping nine-year-olds, punishing ‘immodest’ women with rape or assault, etc.

Understanding the differences between Sharia law and Constitutional law highlights why constitutional law must remain the only governing legal authority in the United States.

No accommodation of Sharia as a parallel or overriding system can occur without eroding these essential safeguards for all Americans. This clarity on the conflicts leads naturally into examining Texas’s leadership response and the broader national momentum to protect our constitutional framework.



Attention: Five core constitutional protections—religious freedom, free speech, equal protection, due process, and humane punishments—conflict directly with traditional Sharia governance.

3. Texas Leadership Actions, Enforcement Challenges, and the Overwhelming Vote to Ban Sharia

Texas has become the focal point of the national debate over Sharia law and constitutional sovereignty, with state leaders taking bold steps to protect American law as the sole governing authority.

Governor Greg Abbott has led aggressive actions against perceived threats. In November 2025, he designated the Muslim Brotherhood—the world’s preeminent Sharia supremacist organization founded in 1928 to restore the Islamic caliphate and funded by nations such as Qatar, Turkey, and Iran—and its prominent American front group, the Council on American-Islamic Relations (CAIR), as foreign terrorist organizations and transnational criminal organizations.




This designation authorizes heightened enforcement, prohibits these groups from purchasing or acquiring land in Texas (impacting mosque ownership and other properties), and opens pathways for asset restrictions.

In September 2025, Abbott signed House Bill 4211 into law, banning residential property developments from creating what critics call “Sharia compounds”—targeting projects like EPIC City that raised concerns over potential discriminatory practices or foreign influence in community governance.

The legislation aims to prevent developments that could enforce Sharia rules or defraud Texans while preserving legitimate religious freedom.



Despite these advances, enforcement challenges persist. Efforts have lagged on key issues such as fully restricting foreign-controlled mosque ownership, preventing the serving of halal food (meat slaughtered according to Islamic ritual and consecrated to Allah, often criticized for inhumane methods) in public schools, hospitals, and prisons, and closing loopholes that allow incremental influence in public institutions.



In response to growing awareness, Texas voters delivered a resounding message during the March 2026 Republican primary. Proposition 10—a simple five-word measure: “Texas should prohibit Sharia law”—received overwhelming support, with approximately 94.81% voting Yes (1,903,489 votes) out of nearly 2 million ballots cast.

This landslide from Republican primary voters creates a powerful public mandate, signaling strong grassroots demand for lawmakers to translate voter will into enforceable policy during the upcoming legislative session.

Texas voters have spoken decisively—the path forward now depends on turning this overwhelming public support into concrete, enforceable legislation that closes remaining gaps and overcomes any resistance.

With such strong leadership momentum and voter resolve, the stage is set for national implications as other states watch Texas lead on protecting constitutional sovereignty.

⚠ Attention: The vote sends a clear mandate: Texas must ensure that foreign or religious legal systems cannot influence its courts or institutions, preserving constitutional law as the sole authority while turning strong voter support into enforceable legislation and national leadership.

4. National Political Momentum and Legislative Push to Ban Sharia

What began as a Texas-centered effort is rapidly expanding into a national movement to safeguard constitutional sovereignty against Sharia influence. The debate is no longer confined to the Lone Star State.

In December 2025, U.S. Representatives Keith Self (TX-03) and Chip Roy (TX-21) launched the Sharia-Free America Caucus in the House of Representatives. Co-chaired by Self and Roy, the caucus counters what members describe as the alarming rise of Sharia—a dominating force incompatible with the U.S. Constitution—and has quickly gained traction.

By early 2026, the caucus had grown significantly: from an initial surge to 26 members in January, to 33 by February's first press conference, and reaching 41–44 members from 20–21 states in recent updates. Supported by Senate voices like Sen. Tommy Tuberville (R-AL), the group includes prominent Republicans such as House Majority Whip Tom Emmer (MN-06), Reps. Byron Donalds (FL-19), Andy Biggs (AZ-05), and others from states including Florida, Arizona, Pennsylvania, and more.

The caucus held its first press conference, highlighting Sharia as a culture of violence and domination that threatens American values, and is advancing legislative efforts to ensure constitutional law remains supreme.

This momentum includes federal bills like the Preserving a Sharia-Free America Act (H.R. 5722, introduced by Rep. Chip Roy in October 2025), which seeks to restrict immigration benefits for those adhering to Sharia; the No Sharia Act (introduced by Sen. Tommy Tuberville and Rep. Randy Fine); and the Defeat Sharia Law in America Act (S. 3887,

introduced by Sens. John Cornyn (R-TX) and Tommy Tuberville in February 2026), which amends the Civil Rights Act to prohibit discrimination based on Sharia enforcement.

Congressional hearings, such as the House Judiciary Subcommittee's February 2026 session on "Sharia-Free America," have examined how alternative Sharia-based institutions may violate federal law and the Constitution.

“Phase three is to make banning sharia a voting issue across this state in the November elections and across the country... Make it a litmus test... And then we need to hold them accountable in phase four to living out the mandate and effecting the prohibition of Sharia everywhere in America.” –Frank Gaffney

Former Muslims and even some practicing Muslims who escaped Sharia-governed countries have joined the warnings, sharing realities of life under the system—including loss of basic freedoms (like pet ownership, as dogs are considered unclean in some interpretations) and women's rights—along with the use of violence to enforce submission.

Supporters argue that arbitration agreements, contracts, and legal precedents often cross state lines, making clear federal standards essential to prevent religious legal frameworks from influencing civil law through dispute resolution or private agreements.

Texas is viewed as the decisive battlefield: success here—building on the 95% voter support for Proposition 10 in the March 2026 Republican primary—serves as a model and catalyst for nationwide protections before Sharia infrastructure becomes entrenched.

The campaign strategy involves four phases: securing gubernatorial enforcement in Texas, leveraging the recent voter mandate, making Sharia a voting issue nationwide, and holding elected officials accountable for delivering actual prohibitions.




